


Mitt Romney's Bundlers

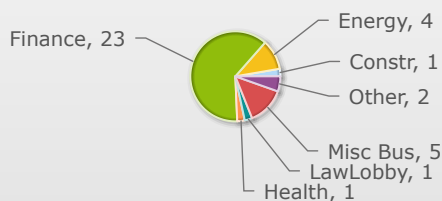
